

Mileposts

The collection of major cases and other specific achievements—the "mileposts"—included in the NJEJLA is one gauge for measuring positive change in laws and legal procedures in New Jersey. The listings highlight select reported and unreported decisions, as well as key non-case achievements that had substantial consequence. Taken as a whole, these mileposts represent an overall increase in the legal system's fairness toward disadvantaged people and their perception and expectation of receiving fair treatment.

Circle of Honor

Analogous to "halls of fame" for other institutions, the Circle of Honor memorializes those who have made extraordinary achievements in advancing equal justice, and whose efforts and lives stand as enduring paradigms for others to emulate. Each has played a role in bending the moral arc of the universe toward justice.

The history of Legal Services is a rich one, replete with pioneer advocates who have dedicated their lives to furthering the cause of civil justice. Through these oral histories, advocates share their stories of inspiration, perseverance, and achievement.

Melville "De" Miller, Jr.

De Miller, President Emeritus of Legal Services of New Jersey, was one of LSNJ's five original incorporators in 1973 and was instrumental in establishing the statewide Legal Services system that exists today. His lifelong pu suit of justice and achievements on behalf of low-income clients in New Jersey are unparalleled.
