The application of Donna Smallwood by her attorney, Larry Lesnik, respectfully shows:

THAT APPLICANT filed her voluntary petition in bankruptcy in the above-entitled proceeding on October 11, 1978.

THAT Washington Towers was duly listed as a creditor on Schedule A-1 of Applicant's schedule of debts under the name of Raymond Marzulli a/k/a Marzulli Realty Co., the agent of Washington Towers, for rent allegedly due and owing from June 1, 1978 to October 31, 1978.

THAT prior to the filing of the Application herein and on or about September 29, 1978, Washington Towers commenced an action against Donna Smallwood in the Essex County District Court, Landlord-Tenant Division, Docket No. T 441464 by which action Washington Towers seeks to obtain a judgment of possession based on rents allegedly due and owing from June, 1978 to September 30, 1978, plus rent due as of the return date of the hearing.

THAT since the filing of the petition in bankruptcy herein, Washington Towers by and through its attorney has refused to restrain from prosecuting its action and unless restrained from so doing will continue said prosecution, presently returnable on October 16, 1978.

THAT if said stay is not granted, Applicant will suffer irreparable harm in that she will be evicted from her premises by virtue of the aforesaid tenancy action filed by Washington Towers.

THAT to allow Washington Towers to continue said action will thwart the purpose of the Bankruptcy Act.

WHEREFORE, Applicant prays that an Order be made prohibiting said Washington Towers and its attorney, agents or
employees and any of them from prosecuting said action described
above until such time as the question of Applicant's discharge
in the within proceedings be finally determined; and Applicant
prays further that all said persons be restrained from taking
any further action in said action for possession until the
hearing and determination of this Application, and further
that the Essex County District Court be enjoined from hearing
the subject tenancy action until further Order of this Court.
