This matter having been heard on January 8, 1980, in the presence of Richard A. Goldberg, Esq., and Alfred Donnarumma, Esq., Attorneys for Plaintiffs, Seymour Lichtenstein, Esq., Attorney for Defendants, Housing Authority of Elizabeth, Edward Smolen,

Charles Harris, Edward Moran, Chris Padas, M. Alberto Planas, Craig Exelbert, Mary Ann Dempsey and J. William Farley, Jr., and Luis Bello, Esq., Assistant City Attorney, Attorney for Defendants City of Elizabeth, Elizabeth Police Department, Joseph Brennan, and Unknown Elizabeth Police Officials upon Complaint in Lieu of Prerogative Writ and Answers, and the Court having heard and considered the testimony of Plaintiffs' witnesses, and it appearing that Defendant City of Elizabeth distributed law enforcement records pertaining to juveniles and that Defendant Housing Authority of Elizabeth and other city agencies received and used such records;

It is on this 1914 day of Must 1980, ADJUDGED that Defendants' actions were illegal and contrary to N.J.S.A. 2A:4-65; it is further

ORDERED and ADJUDGED that the Defendants City of Elizabeth and Elizabeth Police Department are hereby immediately and permanently enjoined and restrained from distributing or disseminating in any form all law enforcement reports, summaries or other records pertaining to or in any manner identifying juveniles (except to those individuals and agencies specifically named in N.J.S.A. 2A:4-65); and it is further

ORDERED and ADJUDGED that Defendants Housing Authority of Elizabeth and subdivisions of Defendant, City of Elizabeth, are hereby immediately and permanently enjoined and restrained from receiving, accepting, maintaining or using in any manner all

law enforcement reports, summaries or other records pertaining to or in any manner identifying juveniles; it is further

ORDERED and ADJUDGED that Defendant Housing Authority of Elizabeth shall grant representatives of Union County Legal Services Corp., attorneys for Plaintiff, and a representative of the attorney for Defendant City of Elizabeth reasonable access to the files of all present tenants of Pioneer Homes, Migliore Manor and Mravlag Manor for the purpose of collecting and destroying any law enforcement reports, summaries or other records pertaining to or in any manner identifying juveniles and any memorandums, records, reports, notes or other documents containing information drawn from such law enforcement reports, records or summaries; and it is further

ORDERED and ADJUDGED that Defendant Housing Authority of Elizabeth is hereby immediately enjoined and restrained from removing any papers, records, reports; memorandums, notes, summaries or other documents from the files of present tenants of Pioneer Homes, Migliore Manor and Mravlag Manor pending completion of the review of these files by representatives of Union County Legal Services Corp., as provided above; and it is further

ORDERED and ADJUDGED that this Court will retain jurisdiction of this matter for the purpose of resolving any disputes which may arise out of the implementation of this Judgment and Order.
