LEGAL SERVICES OF NEW JERSEY NEWSLETTER FOCUSES ON SAFEGUARDS FOR THE STATE'S LGBTQ+ COMMUNITY

EDISON — The latest newsletter of Legal Services of New Jersey (LSNJ) centers on the

many programs and legal protections available for LGBTQ+ residents.

The newsletter notes such "historic protections come at an important and urgent time"

because "across the U.S. anti-LGBTQ+ and, in particular, anti-trans legislation, rhetoric, and

discrimination threaten a vulnerable community."

Just this past April, Governor Phil Murphy signed an executive order essentially making

the state a safe place for anyone seeking or providing gender-affirming healthcare that includes

mental health services, surgery, hormone and replacement therapy, among many other treatments

and therapies. Further, the executive order directs all state departments and agencies to protect

against repercussions or backlash for providing, receiving, seeking assistance in, or traveling to

New Jersey for gender-affirming healthcare.

Additionally, there is a 2017 state law that increased protections and requirements for transgender-related care. That statute applies to Medicaid services, as well as private health insurers and state health plans.

The state's Law Against Discrimination (LAD) was expanded in 1992 to protect lesbians, gay men and bisexuals. It was further expanded in 2007 to cover transgender, gender nonconforming, and non-binary people. Under LAD individuals have the have right to self-identify, dress according to their gender identity, and be addressed by their name, title and pronoun without being required to show proof of gender identity.

The article notes Garden State Equality, a statewide LGBTQ+ advocacy rights organization in Asbury Park, has mapped more than 200 LGBTQ+ friendly healthcare providers across the state. The newsletter also includes an article on how to get a name change, as well as a piece detailing rental assistance programs and what to do if a landlord doesn't comply.
