### **LATEST LEGAL SERVICES NEWSLETTER FOCUSES ON 2023 FEDERAL INCOME TAX RETURNS**

EDISON — Details for low- and moderate-income New Jerseyans about filing federal income tax returns for 2023 are the focal point of the latest newsletter of Legal Services of New Jersey (LSNJ).

The bilingual publication, “Looking Out For Your Legal Rights,” is accessible online at [www.lsnjlaw.org](http://www.lsnjlaw.org).

The focus on key aspects of federal income taxes is particularly timely since the April 15 tax filing deadline is fast approaching.

The newsletter stresses that even though many people may have had incomes in 2023 below the threshold required for filing a tax return, they may want to file anyway by the April 15 deadline because they could still qualify for a refund or some other financial benefits, such as the Earned Income Tax Credit (EITC). Potential recipients of the EITC must have incomes below \$63,398 and be citizens or resident aliens with Social Security numbers.

The newsletter includes a chart people can use to determine if they are required to file a return, as well as definitions and qualifying aspects of key IRS benefits.

Another point underscored in the publication is that people with incomes under \$64,000 should avoid going to paid tax preparers because they can get such help free from Volunteer Income Tax Assistance (VITA) or Tax Counseling for the Elderly (TCE) and other sources by calling 1-800-906-9887 or going to <https://irs.treasury.gov/freetaxprep>.

Additionally, anyone with adjusted gross incomes under \$79,000 can qualify for commercial tax preparation software and have their returns prepared and filed at no cost. Details can be found at [www.irs.gov](http://www.irs.gov) and clicking the “File your taxes for free” link.

Meanwhile, individuals who need help with tax issues may qualify for assistance from LSNJ's Tax Legal Assistance Project (TLAP) by applying online at [www.lsnjlawhotline.org](http://www.lsnjlawhotline.org) or by calling 1-888-LSNJ-LAW (1-888-576-5529).

The newsletter advises that people anticipating refunds should steer away from firms that offer instant cash in advance of the refunds — actual loans from which fees and interest are deducted. It also is advised to choose private preparers carefully.

The publication notes a six-month filing extension is available if sought before the April 15 deadline.
