## New Jersey Equal Justice Library and Archive Circle of Honor

For 59 years, Legal Services in New Jersey has been a central force in the struggle for civil legal justice in this state. Through the New Jersey Equal Justice Library and Archive (NJEJLA), LSNJ preserves key materials relating to the quest for equality in New Jersey, to serve as a resource for educators and all residents, with collections in both digital and physical formats.

A major component of the NJEJLA is the Circle of Honor, heralding those who have made extraordinary achievements in advancing equal justice, and whose efforts and lives stand as enduring paradigms for others to emulate. The Circle of Honor furthers the NJEJLA's historical, educational, and preservation goals, as well as a fourth key purpose—inspiration.

Tonight's Circle of Honor inductee, the Honorable Sheila Y. Oliver joins Michael R. Cole, Chief Counsel to Governor Thomas H. Kean and former chair of the LSNJ Board of Trustees; The Honorable James H. Coleman, Jr., former justice, Supreme Court of New Jersey, and former chair of the LSNJ Board of Trustees; Robert Del Tufo, former attorney general of New Jersey and former member of the LSNJ Board of Trustees; Douglas S. Eakeley, former chair of the LSNJ Board of Trustees and former chair of the LSC Board of Directors; Kenneth C. Frazier, former president and CEO of Merck and Co., Inc., current executive chair of Merck's board of directors, and former member of the LSNJ Board of Trustees; The Honorable Thomas H. Kean, 48th governor of New Jersey; Wynona M. Lipman, New Jersey's first Black female state senator; Melville "De" Miller, Jr., co-founder and former president of LSNJ; The Honorable Deborah T. Poritz, former chief justice, Supreme Court of New Jersey, and former chair of the LSNJ Board of Trustees; The Honorable Joseph H. Rodriguez, United States District Judge for the District of New Jersey; Stanley C. ### The Lipman-Franks Award

The Lipman-Franks Award is named for two esteemed state legislators, Wynona Lipman and Robert Franks, who, acting in a bipartisan fashion, played especially central roles in developing early financial support for Legal Services and in securing greater and more equal justice for the disadvantaged.

## **Equal Justice Medals**

Equal Justice Medals were first awarded in 1983. They recognize and celebrate the pro bono efforts of individuals, law firms, and organizations that have made important contributions to securing greater justice for disadvantaged people, especially through legal processes and the judicial system.

#### **Major Contributors**

Recognizing individuals, law firms, and organizations that have made major contributions to Legal Services' pro bono programs throughout the state from February 2023 to August 2024. Major contribution for individuals is defined as 40 hours providing full representation on one or more pro bono cases; for firms, 100 hours collectively. A special designation is given for in-house volunteers to recognize those individuals who have spent more than 100 hours providing legal assistance to clients on a pro bono, uncompensated basis in a Legal Services office.

#### **Exceptional Contributors**

The Exceptional Service category of Equal Justice Medals is for those individuals who have, in one year or over a number of years, made extraordinary pro bono contributions to their affiliate programs, with awardees honored from each New Jersey Legal Services program.

#### Significant Contributors

Equal Justice Medals are awarded to recognize and honor those firms, community organizations, board members, and individuals that made significant contributions to Legal Services and provided much needed services to the low-income community over time.

#### Full Representation Contributors

Recognizing individuals, law firms, and organizations that have provided full representation to at least one Legal Services referral between February 2023 and August 2024.

Shaun Peterson is a graduate of The College of New Jersey (TCNJ) and Seton Hall Law School. He is in his fifth year as an associate at Hoagland, Longo, Moran, Dunst & Doukas, LLP in New Brunswick, where he is a member of the firm's Transactional Group. Practice areas include property tax appeal, commercial and residential real estate transactions, landlord-tenant, and municipal government. Peterson began volunteering with Central Jersey Legal Services in 2021. His first case involved helping a client obtain a guardianship. Peterson expressed that he enjoys this area of law because he is able to get the client the help he or she needs to take care of an incapacitated individual. He also provides pro bono representation for cases involving name changes, believing that it is important for the client to feel comfortable with their own identity after a divorce. Peterson enjoys providing pro bono services to our clients because he believes that those in need of legal assistance should not be denied representation due to their socioeconomic status.

#### Carl Levitt, Esq.

For five years, Carl Levitt was a staff attorney in the ENLS housing unit dedicated to the cause of equal justice and especially to the cause of improving housing conditions and opportunities for Essex County's low-income families. In 2023, Levitt left ENLS for private practice. Now, as a solo practitioner, Levitt has committed himself to empowering individuals to take action through advocacy, education, relationship building, and litigation. A regular contributor to ENLS' Private Attorney Involvement (PAI) program, Levitt handled eight cases for full representation in 2024, covering the recovery of security deposits, illegal evictions, and other tenancy matters.

#### Bill Singer, Esq.

Bill Singer of Singer & Fedun is a nationally recognized legal specialist and pioneer in the area of LGBTQ+ rights. Singer has been a pro bono volunteer for LSNJ since 2016, when he agreed to represent every single transgender or gender non-binary client seeking a legal name change. These cases also involve helping clients with gender marker changes for their

official identification documents. Not only has Singer represented dozens of LSNJ clients in this regard; he has also offered support and training to other volunteers, providing guidance through the name and gender marker change process and addressing best practices in representing and working with transgender and gender non-binary clients. Singer and members of his firm, collectively, have given generously of their time to assist Legal Services clients. Singer is the recipient of numerous awards, including most recently, the Dan Bradley Award presented by the National LGBTQ+ Bar Association in 2024.

#### Lori Hirsch, Esq.

Lori Hirsch worked at Merck for over 25 years as managing counsel. Most recently, she was vice president for Regulatory Compliance and External Engagement at Bristol Myers Squibb. Over the past year, Hirsch has volunteered almost every week for LSNWJ's eviction diversion clinic at the Somerville landlord-tenant court, where she represents tenants facing eviction. Taking cases on the spot, Hirsch typically handles one to two cases at a time, providing immediate and critical advocacy for individuals at their most vulnerable. Hirsch's pro bono service with LSNWJ began during her career at Merck, where she first volunteered and led a team of Merck volunteers at the tenancy clinic. Following her retirement, she reached out to continue her advocacy for tenants, underscoring her deep commitment to access to justice. Hirsch is not only tremendously reliable and knowledgeable, but she also brings a compassionate and caring approach to every case she handles, ensuring tenants feel supported during an incredibly stressful time in their lives.

#### Scura Wigfield Heyer Stevens Cammarota LLP

Scura Wigfield Heyer Stevens Cammarota LLP has been providing pro bono legal assistance to NNJLS clients since 2008, when partner John J. Scura III began representing clients in the bankruptcy process and later expanded his role by hosting regular bankruptcy clinics with clients. During the COVID-19 pandemic, David Stevens, Esq., transitioned to a virtual format for the bankruptcy clinics and assumed oversight of NNJLS client referrals and case placement. All of the Scura volunteers go above and beyond, offering legal representation and advising clients on post-bankruptcy best practices to help them maintain financial stability. In 2024, the Scura Firm volunteers assisted 28 clients with their bankruptcies. Those volunteers include Aiden Murphy, Esq., Paul Evangelista, Esq., Jamal Romero, Esq., Diana Woody, Esq., Mr. Stevens, and Vasti Majano, Esq. NNJLS is deeply grateful for the Scura Firm's dedication, compassion, and profound impact on the lives of our clients. Their work truly exemplifies the values of our organization.

Since August 2023 alone, the firm has accepted four guardianship cases, a children's SSI case, and many divorces. Freidel and Kramer also always request a new case when they finish one. They have a heart for underserved people, and it shows. Their kindness, thoroughness, and professionalism are unmatched.

#### Covenant House New Jersey, Human Trafficking Victim Services

Covenant House New Jersey's Human Trafficking Victim Services team has been an indispensable partner of the LSNJ PROTECT Anti-Trafficking Project since the early days of the initiative. Their dedicated case managers play a crucial role in stabilizing trafficking survivors so they can successfully address their legal matters and rebuild their lives. Survivors often exit their trafficking deeply traumatized and lacking basic necessities—shelter, financial resources, social support, sometimes even adequate clothing. Through their 24-hour hotline, Covenant House's team provides immediate, comprehensive assistance as New Jersey's statewide human trafficking service provider. Their support spans every aspect of a survivor's recovery journey, from providing transportation to attorney meetings and coordinating medical care, to assisting with grocery shopping and accompanying clients to government offices for benefits applications. Perhaps most critically, they secure safe housing for survivors who have nowhere else to turn. If a survivor has a need, Covenant House's case managers have likely found a way to address it. The team's exceptional responsiveness and collaborative spirit make them invaluable partners in serving trafficking survivors.

#### Legal Services of Northwest Jersey

#### David Culley, Esq.

David Culley is Board of Trustees Treasurer for the Hunterdon County Bar Association, a veteran, and a superintendent of Veteran's Haven North, a VA-operated transitional housing program for veterans experiencing homelessness. In 2022, Culley reached out to LSNWJ to identify support for the veterans residing at Veteran's Haven North, whose legal issues were impacting their housing and income stability. Culley's leadership and partnership were instrumental in the launch of legal clinics, enabling LSNWJ to schedule regular meetings and provide legal assistance to veterans. His proactive efforts in outreach to veterans have ensured that LSNWJ is able to provide assistance to veterans on expungements, public entitlements, family, and consumer matters. Culley's dedication to the veteran community has transformed countless lives. He tirelessly identifies resources and assistance for veterans; his compassionate and thoughtful approach fosters trust and empowers veterans to seek the help they need. Through his partnership, the number of veterans served by LSNWJ has tripled, creating lasting stability for those who have served our nation.

#### Georgene Sfraga Panza, Esq.

Georgene Sfraga Panza began volunteering with NNULS in 2008, following her retirement as a Vice President at New York Life Insurance Company. In 2011, she transitioned to an inhouse volunteer role, committing to weekly service for at least 10 weeks. Fourteen years later, she remains a dedicated weekly volunteer. Currently, Panza supports clients through the uncontested divorce process, guiding them through the complaint, explaining the service of process, and preparing them so they know what to expect. In the past 18 months alone, she has assisted over 35 clients in navigating this process. Over 14 years with NNJLS, Panza has helped hundreds of clients. NNJLS is deeply grateful for her unwavering dedication and the significant impact she has had on our clients' lives.

#### South Jersey Legal Services

#### Expungement Law Project at Rutgers Law Camden

The Rutgers Expungement Law Project clinical program (the "Project") has made significant contributions to pro bono services and has been particularly valuable in recent years to the SJLS Private Attorney Involvement Program (PAI). Professor Meredith L. Schalick started the Project in 2018. Through its association with SJLS PAI, 18 clients were initially financially screened and referred for expungement assistance at the start of the clinical program. Each year since, Schalick has requested that SJLS refer additional eligible clients to the Project for assistance. After intake, screening, and document gathering by SJLS PAI, the Project pairs clients with a group of Rutgers Law students who assist the clients in filing expungement applications. Almost two hundred clients have been referred to the Project to date. In addition, in 2018 and 2019, the Rutgers Project hosted several expungement community outreach events to help bring awareness to local individuals and community groups of the expungement services available through Rutgers and SJLS. In 2022, 2023, and 2024, PAI and Rutgers worked together to host expungement events at various locations throughout South Jersey. The Project serves a very real need in the community and has made very significant contributions to the Legal Services community. Finally, the individuals who work in the Rutgers Project-Clinical Professor of Law Meredith L. Schalick, Associate Professor of Law Sandra Simkins, Viktoria Zerda, Esq., and the many law students over the years—consistently strive to accept as many cases as possible and to achieve the best outcome for clients.

#### New Jersey Senate Majority Leader M. Teresa Ruiz

Senator Ruiz became the first Puerto Rican elected to the Senate in 2007 and is currently the highest-ranking Latina legislator in state history. She is the Senate Majority Leader and Vice-Chair of the Senate Legislative Oversight Committee, and previously served as chair of the Senate Education Committee. Throughout her time in the Senate, Ruiz has fought for equity in educational spaces and is the leading force in expanding access to early childhood education throughout the state. She also spearheaded the law building on the federal free and reduced meal program so that all qualifying students could receive breakfast and lunch at no cost, eliminating the reduced category.

Senator Ruiz has focused on expanding employment opportunities for underserved communities, sponsoring bill packages to expand apprenticeship programs in the state. The enacted apprenticeship package created more accessible pathways to careers in high-growth industries by incentivizing business participation in apprenticeship programs. In addition, she has taken a targeted approach to mitigating the barriers that prevent people of color from obtaining and retaining full time teaching positions by advancing legislation to establish educator apprenticeship programs, provide loan redemption opportunities, and expand alternate route programs.

Furthering her agenda to support new mothers, parents, and families, in 2021 Senator Ruiz sponsored a law to provide all New Jersey parents access to one cost-free newborn home visit, creating the most comprehensive nurse visitation program in the nation. Senator Ruiz was also the prime sponsor of a 2020 law to allow candidates to use campaign funds to cover childcare expenses incurred due to campaign activities.

The Senator received a bachelor's degree from Drew University. She was a 2010 Aspen Institute Rodel Fellow and a graduate of the Harvard Kennedy School's Senior Executives in State and Local Government Program. She is vice chair of the Essex County Democratic Party and deputy chief of staff to Essex County Executive Joseph N. DiVincenzo, Jr. She served as a delegate to the Democratic National Conventions in 2004, 2008, 2012, and 2016.

A steadfast supporter of New Jersey's Legal Services programs, Senator Ruiz is deeply aware of the need for civil legal services for the low-income community in New Jersey. She has worked with LSNJ and its leadership in various capacities, including legislative advocacy to address important civil legal issues and to promote a deeper understanding of "True Poverty," community education and awareness, and crucial support in LSNJ's funding efforts, all to help secure equal justice for those in poverty and strengthen families in New Jersey. Senator Ruiz's accomplishments and her dedication to equal justice cannot be overstated.

The New Jersey Equal Justice Library and Archive (NJEJLA) was launched in 2014 in order to chronicle the arc of justice in New Jersey and provide a resource for educators and students.

The Circle of Honor furthers the NJEJLA's historical, educational, and preservation goals, and serves as an inspiration to those committed to justice.

## Sheila Yvette Oliver

(July 14, 1952 - August 1, 2023)

#### Former Lieutenant Governor of New Jersey

Sheila Yvette Oliver served as New Jersey's Lieutenant Governor from January 2018 until her passing in August 2023.

Raised in an ethnically diverse Newark neighborhood and a politically-engaged family, Oliver was encouraged from an early age to be a critical thinker and to advocate for social justice. An avid reader and historian, she credits two books—"A Tale of Two Cities" and "The Grapes of Wrath"—with further deepening her sensitivity to the effects of inequality.

She graduated cum laude in 1974 with a Bachelor of Arts in sociology from Lincoln

University, the oldest of the country's Historically Black Colleges and Universities and stated in a 2021 Black History Month interview with the Governor's office that prior graduates such as Thurgood Marshall and Langston Hughes, "without question, influenced my thought and my participation in advocacy and progressive social issues that are of benefit of the Black community."

From Lincoln University, Oliver went on to earn her Master of Social Work from Columbia University in 1976 before launching her long and distinguished career advocating for equality and social justice.

Oliver served on the Board of Education of the East Orange School District (1994 – 2000), including one year as Board President. She served on the Essex County Board of Chosen Freeholders from District Three (1996 – 1999) and taught college-level courses as an adjunct faculty member at Essex County College and Caldwell University. Oliver then went on to represent the 34th legislative district in the New Jersey General Assembly (2004 – 2018), where she served on the Commerce and Economic Development Committee, the Transportation and Independent Authorities Committee, the Joint Committee on Economic Justice and Equal Employment Opportunity, and the Joint Committee on the Public Schools. In 2010, she became the first Black woman to serve as speaker of the General Assembly—a position she held until 2014.

## **NJEJLA Circle of Honor**

In 2017, Democratic gubernatorial nominee Phil Murphy chose Oliver as his running mate. With that win, Oliver became the first Black woman to serve as lieutenant governor of New Jersey and the first woman of color elected to statewide office in New Jersey. In addition to her role as Lieutenant Governor, Oliver served as Commissioner of the Department of Community Affairs, where she led efforts to strengthen and expand initiatives for fair and affordable housing, community revitalization, and homelessness prevention.

Former New Jersey Senator Loretta Weinberg remembers Oliver as a partner in efforts such as marriage equality and pay equity. "She was there as a leader, as a voice, and somebody who helped us get through the first, strongest pay equity law of any state."

Always a friend to Legal Services, "Sheila Oliver was unwavering in her support for equal justice for all and for the Legal Services in New Jersey statewide system," says LSNJ President, Dawn K. Miller, Esq.

Says U.S. Congresswoman Bonnie Watson Coleman, "She was eloquent and elegant—a brilliant speaker and an example for young women, Black or otherwise."

Niece Renee and nephew Charles—both heavily influenced by their aunt throughout their lives—have spearheaded the new Sheila Y. Oliver Civic Association since her death in 2023. The Association strives to keep her memory alive by "empowering underserved communities to achieve both economic and social success, as well as educating and developing young women of color who are interested in government, public policy, and community organizing." They recall their Aunt Sheila's ability to treat everyone, regardless of stature or economic status, with dignity and respect. "She used to say to me, 'The only time you look down on a person is if you're offering a hand to help them up,'" says Charles. And Renee—"All the awards and all the titles are obviously good and grand, but I think Sheila Oliver was truly, truly about helping those who need it."

Robert Del Tufo was born in 1933 in Newark. As attorney general of New Jersey, he aggressively prosecuted environmental violations and spearheaded the Office of Bias and Community Relations. He served on the LSNJ Board of Trustees for over three decades.

## Douglas S. Eakeley

LSNJ Board of Trustees; Former Chair, LSC Board of Directors (2022)

Douglas Eakeley was born in Morristown, New Jersey, and graduated from Yale Law School. A steadfast supporter of Legal Services for his entire career, Doug served as board chair of both the national Legal Services Corporation and Legal Services of New Jersey.

## Kenneth C. Frazier

Executive Chair of the Board, Merck and Co., Inc. (2017)

Kenneth C. Frazier was raised in North Philadelphia and graduated from Pennsylvania State University and Harvard Law School. His extensive pro bono service includes representing a death row inmate and expanding the pro bono program at Merck & Co.

### The Honorable Thomas H. Kean

#### 48th Governor of New Jersey (2014)

The Honorable Thomas H. Kean, 48th Governor of New Jersey, was born in New York City into a family of public service stretching back to New Jersey's first governor, William Livingston. Kean served as Governor from 1982 to 1990 and is celebrated for his bipartisan style.

### Wynona M. Lipman

#### New Jersey's first Black Female State Senator (2017)

Senator Lipman was born in LaGrange, Georgia, and attended Talladega College, Atlanta University, and Columbia University. She taught at Essex County Community College before entering politics and, in 1971, became New Jersey's first black female senator.

### Melville "De" Miller, Jr.

#### Co-Founder and Former President (2022)

De Miller was one of LSNJ's five original incorporators in 1973 and was instrumental in establishing the statewide Legal Services system that exists today. His lifelong pursuit of justice and achievements on behalf of low-income clients in New Jersey are unparalleled.

### The Honorable Deborah T. Poritz

#### First Female Chief Justice, Supreme Court of New Jersey (2017); LSNJ Board of Trustees

Chief Justice Deborah T. Poritz was born in Brooklyn, studied English and American Literature at Columbia University, and received her J.D. from the University of Pennsylvania Law School. In 1996, she became the first female Chief Justice of the New Jersey Supreme Court. Chief Justice Poritz served as LSNJ Chair of the Board from 2011-2017.

### The Honorable Joseph H. Rodriguez

#### United States District Judge for the District of New Jersey (2023)

The Honorable Joseph H. Rodriguez earned his law degree from Rutgers Law Camden in 1968 and became New Jersey's first Latino District Court judge in 1985. He served on the first board of Camden Legal Services and has held a number of important positions, including as the state's Public Advocate under Governor Thomas H. Kean.

### Stanley C. Van Ness

#### First Public Advocate, State of New Jersey (2022)

Stanley Van Ness was born in Somerville, New Jersey, and served in the Air Force before graduating from Rutgers School of Law. He served as counsel to Governor Richard J. Hughes; was the state's first public defender; and, in 1974, became the first Public Advocate of New Jersey.

### **Bonnie Watson Coleman**

U.S. Representative, New Jersey's 12th Congressional District (2019)

Congresswoman Watson Coleman was born in 1945 in Camden, New Jersey. Her career began with the State Division on Civil Rights and the Department of Transportation. She then joined the NJ Assembly for 18 years before winning the seat for New Jersey's 12th Congressional district.

### Loretta Weinberg

#### Former Senate Majority Leader, 37th Legislative District (2019)

Senator Weinberg was born in New York and graduated from UC, Berkeley. She began in local and county politics and spent 12 years in the Assembly before being elected to the Senate in 2005. She has been on the forefront of issues affecting women and the LGBTQ community.

### The Honorable Robert N. Wilentz

#### Former Chief Justice, Supreme Court of New Jersey (2019)

Chief Justice Wilentz, born in 1927 in Perth Amboy, served as Chief Justice of the New Jersey Supreme Court from 1979 until his death in 1996. He is remembered for his passion for fairness and his commitment to a responsive, accessible, and diverse court system.
