# Deborah T. Poritz Public Interest Legal Fellowship

This summer, Legal Services of New Jersey will sponsor paid public interest legal fellowships to rising second- and third-year law students. The Poritz Fellowship program seeks to promote awareness of and commitment to careers in public interest law through rewarding summer experiences. It is open to students who will have completed their first or second year of law school as of June 2022.

Past fellows have become employed in New Jersey's Legal Services system as well as other nonprofit public interest organizations.

### Selection Process

As the program sponsor, Legal Services of New Jersey (LSNJ) screens all applicants to identify those with the greatest potential and commitment to public interest work. Promising applicants will receive a preliminary interview with LSNJ and, if qualified, will be referred to participating employers for a final interview and decision.



Placements are typically for a 10-week period. All interns will participate in a multi-day orientation in June and a closing gathering to recap the summer and discuss public interest opportunities.

### The Fellowship Experience

Students placed in this summer program gain experience in a variety of public interest legal issues. While specific responsibilities vary with the participating employer, activities typically include client interviewing, legal and factual research, drafting legal documents, administrative agency appearances and—for students who have completed two years of law school—court appearances and more in-depth case involvement. Fellows interested in policy and research have participated in client needs assessment and other studies, helped draft pleadings on major litigation, and conducted research in education, civil rights, welfare policy, children's issues, housing, and other matters affecting the poor.

### Qualifications

The competitive fellowship program seeks applicants who have demonstrated a commitment to helping the disadvantaged through prior work, extracurricular school activities, and volunteer efforts. Grades, honors, and personal achievements are also important. Rising third-year law students are given a measure of priority due to a special New Jersey court rule under which students employed by Legal Services offices or other legal aid programs may be certified to appear in some state courts. Outstanding rising second-year students will receive the same consideration.

### Compensation

Summer 2021 fellows received a weekly salary: \$1,000 for rising third-year law students, and \$850 for rising second-year law students.

### Sponsored by Legal Services of New Jersey

Since 1990, the fellowship program has been funded in major part by a grant from the IOLTA Fund of the Bar of New Jersey.

We seek applicants who demonstrate both academic achievement and commitment to public interest legal advocacy and representation.
